Permitted to: [1] voluntarily surrender a Conditional Use Permit (File No. PCUP05-014) for the establishment of a full service sit down restaurant with alcoholic beverage sales (Type 47 ABC License); [2] establish a banquet facility with live entertainment and dancing within a 9,332 square foot area of the basement level and within a 4,447 square foot tenant space on the ground level; and [3] authorize alcoholic beverage sales for consumption on the premises with a catering permit, in conjunction with the banquet facilities, within an existing 33,740 square foot retail building on 0.41 acres of land, located at 317 North Euclid Avenue, within the MU-1 (Downtown Mixed-Use) and EA (Euclid Avenue Overlay) zoning districts. (APN. No. 1048-566-05). Alcohol sales is only permitted by caterer's ABC Type 58 License. Sales of tobacco products as well as use of the premises as a smoking lounge is not permitted. All conditions specified within PCUP16-011 shall be complied with at all times.
